## Writing for Healing and Social Change

No one would wish for a tragedy like ours. My memoir, *Sins of the System: Trauma, Guns, Tragedy, and the Betrayal of our Children*, tells the story of the seven-year drama after my fifteen-year-old nephew shot and killed his father (my brother), mother and three siblings. I took guardianship of my nephew and supported him through his legal, therapeutic, and educational journey. It is a heartbreaking tragedy that was ironed flat by the media coverage, family, and the extended community.

This was not a good guy-bad guy story. I knew that because I knew the generational and cultural stories behind this tragedy. Why would I write a book like this? People say to me “it must have been cathartic.” Yes, I told the story as a *descanso* (Spanish for putting something to rest), pinning it to the page so it doesn’t rattle around in my brain.

More than that, I needed to make something good of the tragedy. I have been lobbying and testifying since 2019 for juvenile justice and gun sense laws. The NM legislature finally passed the Second Chances Bill (SB 64) which abolishes life without parole for people who have committed crimes as children. It also gives these people the opportunity to go before the parole board after serving fifteen years.

After an appeal and resentencing my nephew wouldn’t have gotten the chance to go before the parole board until age 52. He was a fifteen-year-old functioning as a thirteen-year-old who suffered a mental break. Now he will get a chance, much earlier.

I have also lobbied and testified for gun sense laws like the Bennie Hargrove Law on Child Access (HB 9) that also passed this year. It holds gun owners (usually parents) responsible if a child gains access to an unsecured firearm. It’s a misdemeanor for the owner if the child brandishes the weapon and a fourth-degree felony if their actions result in bodily harm. It is intended to encourage responsible gun ownership.

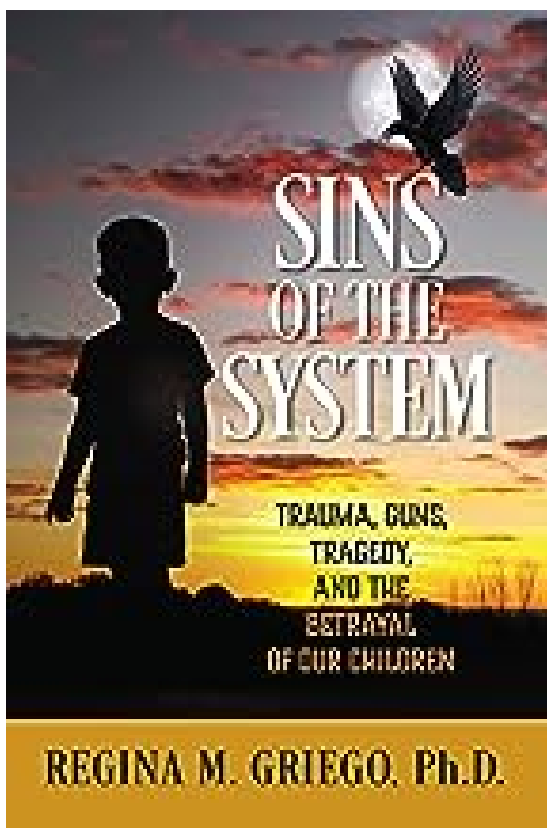

My brother had eight firearms (among them, two AR-15s) and 15,000 rounds of ammunition all accessible to the four children in his household. He was confident that putting them in an unlocked closet and telling his wife and children to use them only if there was an outside threat was enough. After writing the book, I do feel lighter, and I've grown less ashamed and insecure about telling my difficult story. Part of this comes from the community of writers I have joined.

It's extremely supportive when people say that the book was a "page-turner" or ask about my nephew, or say the book influenced how they will parent. I learned about the New Mexico Press Women's (NMPW) organization and their contest. Eager to learn more I joined the organization and entered my book into the 2023 Communications Contest.

I felt so affirmed when I won first place in the memoir/autobiography category! As I learned more about the organization, I realized they were a part of a national organization, the National Federation of Press Women (NFPW), which has been around for more than 80 years. My book was automatically submitted for the national contest, and it was an honor to receive first place in memoir/autobiography there, as well.

Even as a newly minted author, I felt the welcome at the NFPW annual conference. and basked in the support of those amazing writers who came from across the nation. I'm learning how to be a writer and author. It is humbling, starting over as a writer, after a long career as an engineer, but I have found a new home and a community of wonderful people who have welcomed me, and more than that welcomed my story.

## *Holes in Our Hearts* Goes Statewide

NMPW members and other New Mexico authors have been featured in a series of regional book launches and public readings of SouthWest Writers' (SWW) military anthology *Holes in Our Hearts*.

Donna Pedace organized one such event at the Los Lunas Museum of Heritage and Arts, and NMPW member Jim Tritten organized a similar event at the Corrales Community Library, both in July. Book launches and readings followed these in August at the Santa Fe Public Library, organized by Paula Nixon and by NMPW Vice-President, Léonie Rosenstiel, at the Cherry Hills Public Library.

Unlike many anthologies, the public readings of *Holes in Our Hearts* are incorporate the spoken word as part of the healing process. Each reader speaking their innermost thoughts out loud to strangers in an unfamiliar place is a significant milestone and a big step on the road to recovery. It is the reason the Department of Veterans Affairs (VA) sponsors creative writing groups at each hospital and why they have national competitions that feature creative writing.

SWW made a significant contribution to that effort this year. Each veteran in the local creative writing group at Albuquerque's Raymond G. Murphy VA Medical Center got published, and each will be participating in the annual competition, mainly motivated when their work was added to *Holes in Our Hearts*.

Eight authors in the anthology had never been published before, and another dozen had only seen minor letters or the like in print. Two now-published veterans do not own computers or cell phones, and one is legally blind.

Volunteers from the VA Creative Writing Group and SWW helped by getting their submissions into a publishable format. New Mexico Arts (NMA) funded the project with two mini-grants that included distribution of the book to every public library in the state.

Two more public readings are scheduled for November. On Saturday, November 4, SWW will hold a book launch at the UNM Continuing Education site.

Readings will be from Paul David Gonzales, Linda Harris, Carol Kreis, Caroline LeBlanc, Butch Maki, Elaine Carson Montague, Evelyn Neil, Earl Rugen, Regina Washington, Josephine White, NMPW President Sherri Burr and NMPW member Jim Tritten. Following the readings, Jim will also lead a workshop on how to write about the military.

Marine Corps veteran Carl Hitchens has organized a regional book launch and public reading at the Placitas Community Library on Veterans Day, November 11th. Joe Brown, Mark Fleisher, Mike Hays, Carl Hitchens, Paula Nixon, Harper O'Connor, Regina Washington, Dan Wetmore, and Ben White will be featured.

SWW plans to continue supporting the military community with healing through the written word. It has just submitted a 2024 NMA min-grant proposal to provide online instruction for veterans and active-duty service personnel who want to learn how to get started writing memoir.

Participation by veterans in the rural area of New Mexico is an explicit goal of next year's program. The instructor will be Latayne C. Scott, a former NMPW member.

SWW plans to apply to NMA in 2025 to produce another anthology using memoirs produced during the course, as well as submissions from other New Mexico military and veteran family members and caregivers.



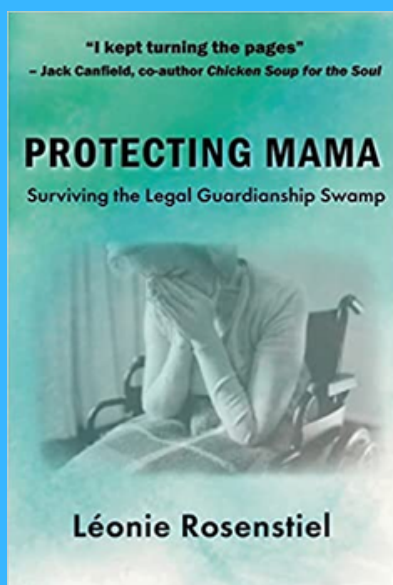

Burr also gave several talks at Renaissance Weekend during the Labor Day conference at Santa Fe's El Dorado Hotel. In one, she discussed New Mexico history and in another The Underground Railroad. She also participated on the closing evening panel.

**Pat Hodapp**, President of the Northern New Mexico New Mexico Chapter of NMPW, reports that her group hosted Navajo actor DezBaa' in conversation with NMPW member **Anne Hillerman** this summer. They expect Sen. Peter Wirth to address them this fall on legislative issues, and Pat herself will discuss book banning.

On November 3, **Léonie Rosenstiel**, NMPW Vice-President, will present a Zoom workshop, *Protecting Mama*, for Well Connected-Front Porch, a national nonprofit serving seniors.
