## From the Desk of the President Cheryl Fallstead

Full conference information and the registration form are later in the newsletter and on our website. I want to say a few words about the proposed change to our historic name. Several years ago, the board spent a lot of time discussing and researching the ramifications of changing our name to a gender- and profession-neutral name. Many state affiliates have made similar changes and the subject was brought to the board again last year as part of the process of updating our bylaws. The board decided the question should be brought to our membership: do we stay with the name that has represented us since 1949 or choose a name that might attract both men and women who work in a broader range of communications fields. You will find articles stating both sides of the issue in this newsletter, as well as the proposed bylaw changes. The first name proposed by to the board by the bylaw subcommittee was "New Mexico Media Professionals," which is what you will see reflected in the bylaw change text. Another proposal was recently approved by the board for consideration at the meeting: "New Mexico Press Women & Media Professionals." Please note the name change will be considered separately from the other bylaw changes, but for the sake of simplicity, the name listed in the proposed bylaws is New Mexico Media Professionals.

So, plan to come to our annual conference to learn, to network, to make your voice heard on issues important to our organization, and to have a good time. We look forward to seeing you there!

Good news! It looks like Albuquerque Press Women may have finally gotten some officer replacements to take over when I step down in June. ### Board To Present Suggested Name Change During State Conference

At the state conference two years ago, members discussed changing the name, New Mexico Press Women, to broaden the organization both in terms of gender and profession. The name change was tabled them and reviewed again at last year's conference, with directions to the board to discuss the issue and report to the members this year.

After considerable discussion and soul-searching, the board has recommended bringing suggested name changes to the members. The suggested name is New Mexico Media Professionals. The vote on this name was not unanimous. There was even a compromise suggested name: New Mexico Press Women & Media Professionals. Two members volunteered to each write a rationalization for changing or keeping the name. Following are those articles: the Pro by Loretta Hall and the Con by Chris Burroughs.

### Are We There Yet? An Argument For Maintaining the NMPW Name

Are we there yet? That's the question New Mexico Press Women need to ask when considering a name change.

Press Women was born out of an era when women were few and far between in the newsroom and when journalism wasn't considered a "safe profession" for women. This organization stepped in and encouraged women not only to become journalists but also to be successful.

Women are still being shut out of good-paying jobs, and men continue to be dominant in all areas of media, including journalism and public relations. Susan Antilla wrote an investigative piece on the topic for CNN on Sept. 18, 2012, where she noted, "Men make up 60 percent of newspaper employees, write 80 percent of newspaper opeds and author most articles in 'thought leader' magazines such as *The New Yorker*, which in 2011 had 242 female and 613 male bylines. She added, "The record for 'new media' is better than print, though men and women are still nowhere near parity." In a March 18, 2010, cover story, surprisingly titled, "Are we there yet?" written by three *Newsweek* women, the authors said 39 percent of the people on the *Newsweek* masthead were women, up from 25 percent in 1970. But men still had the star power, writing 43 of the 49 cover stories the previous year.

In 1993, our own organization, National Federation of Press Women, conducted a study that produced figures showing women in management positions had risen by only one percent per year since 1977. If that rate continued, it would be another 30 years before there would be gender balance in top newspaper jobs in the United States.

And acknowledge, too, the 106-year-old prestigious National Press Club in Washington, DC, excluded women until 1971.

So, are we there yet? I think not! Hence the need for an organization with the name women in it that shows female journalists and media specialists it exists to be an advocate for women in terms of pay and promotion. Of course, men are welcome to join the group. Of course, we want them. But remember our roots and the long road we still have to go for equality.

NFPW has struggled with the concept of changing its name for many years. Denise Tessier, long-time NFPW historian, says in a lengthy article in the organization's March 2010 newsletter, while some states were changing their names to titles like Ohio Professional Writers and Wyoming Media Professionals, New Mexico did not. She wrote, "New Mexico talked about it but did not change. In 1994, NMPW surveyed its members to set goals. The more than 40 responses to a 24-page questionnaire revealed most members remained in NMPW for networking, professional enrichment and friendship. And when asked how members felt about changing NMPW' name, four respondents said to change it, 16 said don't and 10 said change it only if national does."

The organization later revisited a name change again but could come to no consensus, and the name remained Press Women.

We are all aware "press" is obsolete in a period where the numbers of newspapers are shrinking as more and more people get their information and news from the Web. But we should keep in mind the value of a name and the organization – an organization that has served New Mexico media professionals for 64 years. The name is recognizable, has clout , and value. If NMPW changes its name, it will be just one more group in a labyrinth of groups with no name recognition.

If the intent of a name change is to attract new members to NMPW, it may backfire. Author and motivational speaker Richard Brody said in an article in the online publication *Ezine Articles,* Dec. 30, 2013, "A review of all sized organization, whether small, intermediate or large, has indicated nearly all have experienced a reduction in membership over the last couple of decades, with an even larger decline in the past decade. This includes various types of groups, including professional organizations, civic organizations, organized political parties, philanthropies, religious, etc." He noted there are several reasons for this, including 1) People are unwilling to spend money to belong; 2) The organization may not have evolved for modern times; 3) Many organizations suffer from a dearth of leadership; 4) Many leaders are not motivated; 5) Organizations need to address the issue of perceived value. Sounds a bit like Press Women, doesn't it?

I give you more reasons I have noticed on my own why a name change won't bring in new members. Journalists and other media professional, especially people in their 30s and 40s, don't have time to participate. They are busy working and taking their kids to soccer practice, ballet classes, and so on. Kids can't walk or ride their bikes to these events because they are either too far from home or it might be too dangerous. As a result, these responsibilities fall to the parents. In addition, young people in their 20s don't want to attend meetings; they want to go to movies or the bars or work.

I hope the NMPW membership gives careful thought to the idea of a name change. The name, New Mexico Press Women, has served the organization well for 64 years and will continue to do so in the future.

### In Support of Changing NMPW's Name To New Mexico Media Professional

The proposed name, New Mexico Media Professionals, better reflects today's methods of disseminating information to the public. The word "press" brings to mind a nostalgic image of printing presses churning out newspapers. Newspapers are still an important element of the media but so are others including radio, television, and Internet sites. The proposed name would make it clear the organization seeks to support, inform, and encourage professional communicators in all types of media.

The proposed name better reflects the current identity of our organization. We do have a few male members, two of whom currently serve on the NMPW Board of Directors. Men are eligible to hold elective office and, in fact, some have done so. On the other hand, some men resist the idea of joining a "women's organization." Women might feel similarly about deciding to join a (hypothetical) "New Mexico Men in the Media" organization, even if they were assured they were welcomed to do so. The proposed name emphasizes our organization indeed is open to both men and women and exists to help all professional communicators.

New Mexico Press Women was formed in 1950. Then, and for a significant number of subsequent years, women faced limited opportunities in journalism careers. Thanks in large part to organizations like the National Federation of Press Women and its state affiliates, including New Mexico Press Women, many of those barriers to equitable pay, professional acceptance, and advancement opportunities have been largely overcome. However, they must still be protected, along with the equitable treatment of other groups that have faced discrimination on the basis of factors such as race, ethnicity, religion, age, disability, or gender identity. The proposed name change makes it clear this organization supports the development and fair treatment of all media professionals and resists all forms of discrimination.

Changing the name would not be a radical thing to do. We would be in good company among our peer organizations. Of the 30 state affiliates of the National Federation of Press Women, 13 have adopted names that do not include the phrase "press women." Twelve of them have names that are gender neutral and eight do not use the word "press."

Even if the name is changed, this organization will continue to be the state affiliate of the National Federation of Press Women. That affiliation will continue to honor the history and legacy of New Mexico Press Women.

### **Revisions Bring NMPW Bylaws Up to Date**

From time to time any evolving organization needs to review and revise its bylaws. This year a bylaws committee, headed by Vice President Sherri Burr, devoted considerable attention to NMPW's bylaws. These changes are deemed necessary so bylaws better reflect the organization. We will take up the name change recommendation first. Depending on the outcome of that recommendation, the revised bylaws will reflect the accepted name.

### NEW MEXICO PRESS WOMEN BYLAWS

Proposed Changes for Consideration at April 26 Annual Meeting

#### ARTICLE I. Name

The name of the organization shall be New Mexico Media Professionals (hereinafter referred to as NMMP, a nonprofit, taxexempt corporation as defined under 501 (c)(6) of the U.S. Internal Revenue code. NMMP is a state affiliate of the National Federation of Press Women.

#### **ARTICLE II.** Objectives

The objectives of this organization shall be to:Advance opportunities and the professional status of individuals in mass communications.

Exchange journalistic ideas and experiences. Advocate ethics, responsibility and fairness in journalism. Support communications education. Protect First Amendment freedoms.

#### ARTICLE III. Membership

Section 1.

Membership shall consist of professionals in communication and individuals whose vocations and educational pursuits are germane to communication service and the objectives of NMMP.

#### Section 2.

Anyone who qualifies as a professional communicator actively engaged in any aspect of the field of communications may be eligible for membership toNMMP. Membership is open to everyone meeting these qualifications regardless of age, ancestry, color, disability, gender, national origin, race, religion, sexual orientation, gender identity, or veteran status.

Section 3.

a) Professionals who meet qualifications for membership in NMMP but choose not to belong to the National Federation of Press Women will be classified as associate members.

b) The term "associate member" designates that the member is not a member of the National Federation of Press Women. The member classified "associate" will be listed in the state directory, receive the NMMP newsletter and may be a full voting member of NMMP. Associate members may not hold elective offices but may serve in appointive positions.

Section 4.

All chapter officers must be New Mexico Media Professionals members in good standing. "In good standing" shall be defined as being financially current with NMMP dues of membership.

#### Article IV. Officers

#### Section 1.

The elected officers shall be president, vice president, secretary and treasurer.

#### Section 2.

The officers shall be elected by paper ballot at the annual meeting in evennumbered years. The report of the nominating committee shall be transmitted to the members at least 60 days before the annual meeting. Nominations may be made from the floor.

#### Section 3.

The election of a nominating committee of three members shall be held at the annual meeting in oddnumbered years. In the event a nominating committee is not elected at the annual meeting, the NMMP Board of Directors shall elect the nominating committee at the next available meeting.

#### Section 4.

The term of office shall be two years or until their successors are elected. New officers will take office after their installation at the final session of the annual meeting in evennumbered years.

#### Section 5.

Vacancies in any office shall be filled by appointment by the president with approval by the board of directors.

#### ARTICLE V. Governing Body

#### Section 1.

NMMP business shall be conducted by the NMMP Board of Directors and members at the annual meeting. The board shall be the governing body between annual meetings. The executive committee shall be empowered to act for the board on urgent matters between board meetings.

#### Section 2.

The Board of Directors shall consist of the officers, chapter presidents and directors of standing committees. The immediate past president may serve as an exofficio member of the board, with voting privileges. A parliamentarian may act as adviser without a vote. A quorum of the board shall consist of five members.Section 3

The executive committee shall consist of the elected officers (president, vice

president, secretary, treasurer) and district or chapter presidents or their representatives. A quorum of the executive committee must act in the event of need for emergency decisions between board meetings. A quorum shall consist of three members.

#### Section 4

In between board meetings, the president may call for a vote on an issue by email, postal mail, phone, or any other means deemed appropriate. In these circumstances, the board cannot take action unless at least eleven members express their opinion by at least one of the available methods.

#### **ARTICLE VI. Duties**

#### Section 1.

The president shall preside at all meetings and with the approval of the board shall appoint the parliamentarian and directors of standing and special committees, help plan and execute the meetings held during her/his term of office and approve the actions of the vice president.

With the approval of the board she/he may call for an audit at any time during her/his term.

#### Section 2.

The vice president shall act for the president in case the president is temporarily unable to carry out duties of the office. Should the president resign, die, or otherwise be removed from the office, the vice president shall become the president upon confirmation of the board, and the board shall elect a new vice president. The vice president shall also serve as membership director and will be responsible for recruiting new members. The vice president may serve as director of other committees should the need arise. Section 3

The secretary shall record the minutes of all meetings, and shall transcribe them for a permanent file. The secretary will send minutes within three months following meetings to board members.

#### Section 4.

a) The treasurer shall receive and deposit monies belonging to NMMP. b) Monies within the board-approved budget shall be disbursed upon receipt of bills from officers, committee directors and/or members. Disbursement of scholarship funds from the D. Gregory account requires the signatures of treasurer and president, but the checks from the regular checking account will be signed by either the treasurer or the president There shall be no debit cards on NMMP accounts. If a check is ever written for cash, the treasurer or president has to document with a receipt what the cash was used to pay for. The treasurer and the president will receive copies of the monthly bank statements for the regular checking account, the D. Gregory account and the CD account.

c) A budget will be prepared by the treasurer for each fiscal year to be presented to the board of directors for approval at the Fall meeting.

d) The treasurer shall maintain accurate and up to date financial records and the treasurer will give a current financial report at all meetings.

e) The treasurer will certify eligibility of entrants to the annual communications contest

f) The treasurer shall be bonded by NMMP according to usual business practices, and be responsible for paying the bonding fee from NMMP funds in a timely manner. The treasurer shall present a receipt to the board as evidence of payment.
g) The treasurer shall pay the New Mexico Public Regulation Commission or the New Mexico Secretary of State or the appropriate state government agency the annual nonprofit corporation fee before April 15 annually and shall present evidence of payment to the board.

h) The treasurer shall file an electronic IRS Form 990N with the federal government before April 15 annually.

#### Section 5.

The parliamentarian shall advise the presiding officer and the organization on questions of procedure, thus helping safeguard the rights of membership.

#### Section 6.

The historian shall keep appropriate records of the activities of NMMP. A physical or electronic scrapbook of clippings and other materials of interest will be maintained.

#### Section 7.

The public relations director shall disseminate information to local, state and national media.

#### Section 8.

Each officer will relinquish all files to the successor within thirty (30) days after retiring from office. A written report and commentary on the duties of the office shall be included in the files, with a copy for the president's files.

#### Section 9.

The officers will perform the duties as listed above and as in any other documents approved by the organization.

#### Section 10.

An NMMP officer may be removed from office by twothirds vote of the board of directors in the event of disability or other incident rendering the officer unable to perform the duties of office. In the event of such actions, NMMP will provide to the officer under consideration for removal from office thirty (30) days advance written or electronic notice of the meeting at which the board intends to take the action. NMMP will provide to the general membership fourteen (14) days advance notice of the meeting at which the board intends to take the action to enable comment by members.

#### ARTICLE VII. Committees

#### Section 1.

Standing committee chairmen shall include Communications Contest, Communicator of Achievement, Zia Award, High School Communications Contest, Historian, Public Relations, Newsletter, Scholarship, Conference, Bylaws, and Nominating Committee. .

#### Section 2.

Standing committee chairmen shall be appointed by the president with the approval of the Board of Directors with the exception of the nominating committee, which shall normally be elected in odd-numbered years during the annual meeting.

#### Section 3.

Special committees may be appointed as needed by the president with the approval of the board.

#### Section 4.

The president shall serve exofficio by virtue of office on all committees except the nominating committee.

ARTICLE VIII. Meetings

#### Section 1.

NMMP will meet once each year. A quorum for the annual meeting shall be 10 percent of the NMMP members as of March 1 preceding the annual meeting. The following year's meeting place will be determined by vote of the membership at the annual meeting, with invitations accepted at the business meeting. In the event there is no invitation or decision by the membership, or if a change of location becomes necessary the Board of Directors will make the final decision.

#### Section 2.

The NMMP Board of Directors will meet three times each year, in summer, fall and winter in addition to meetings at the annual spring conference.

#### ARTICLE IX. Dues

#### Section 1.

The fiscal year of NMMP will be the calendar year. Dues are due January 1. Dues for new members will be accepted after September 1. Delinquent members shall be removed from the membership rolls.

#### Section 2.

Dues for full memberships and associate memberships shall be determined by the Board of Directors.

#### **ARTICLE X. Amendments**

Amendments to these Bylaws can be proposed by members at large, officers, or by the bylaws committee. Those amendments proposed by officers or the Bylaws committee must be approved by a majority vote of the board at least thirty (30) days before the annual meeting. Amendments to the Bylaws must be approved at the annual meeting of NMMP by a vote of twothirds (2/3) of the members present, provided there has been written notice of the proposed change sent to the membership at least thirty (30) days in advance of the meeting.

#### ARTICLE XI. Disbandment

In case of disbandment of NMMP, funds not already designated shall go to the National Federation of Press Women.

Article XII. Parliamentary Rule

In matters not covered by these Bylaws or by the NFPW Bylaws, NMMP will be governed by the latest edition of Roberts Rules of Order, Newly Revised.

### **High School Communications Contest**

Recently, Chris Burroughs informed the board she would be unable to fulfill the duties of the High School Communications chair. Fortunately, Leota Harriman came to our rescue and is working to get the word out about the contest. She has been assembling a list of high school journalism, media, and yearbook teachers. Cheryl Fallstead has designed a poster and postcard, which has been mailed to 160 high schools. Leota has also contacted several organizations which communicate with these teachers and they have agreed to send e-mails on our behalf, allowing us to reach educators through several avenues.

Entry deadline for this year's contest is March 10.

### Zia Book Award Update

Loretta Hall, Zia Book Award chair, reports 14 books were entered in this year's Zia Book Award. They range from children's picture books to young adult books, including both fiction and nonfiction. Each book will be evaluated by two judges, and the first round of readings is underway. Award recipients will be determined by mid-March, and they will be notified promptly.

# Communicator of Achievement Update

The Communicator of Achievement Award is the highest honor bestowed by New Mexico Press Women upon those members who have distinguished themselves within and beyond their profession. New Mexico's winner will be honored at the state conference in Las Cruces and then forwarded to compete at the National Federation of Press Women's annual conference, September 4-6, in Greenville, SC.

Anyone can nominate a NMPW member for consideration for Communicator of Achievement but must complete the entire packet (See appropriate links below). The nominee must be a living member of both NMPW and NFPW, in good standing for at least two years, with no lapse in membership. Nominees are judged in three criteria: professional achievement (60%); community service (20%); and NFPW/affiliate service (20%). Previous nominees can be nominated again, so long as they have not been selected by NFPW.

The COA Award winner and the runner-up are announced at the awards banquet Saturday, April 26. Each nominee is featured in NFPW's AGENDA newsletter for the prior conference and spotlighted at the awards banquet.

# First Amendment Update

George Bach, First Amendment chair, reports on two new cases before the U.S. Supreme Court as well as updates on two previously reported cases.

#### New:

<u>Moss v. U.S. Secret Service</u>: The Court will hear a case from the Ninth Circuit involving the contours of Secret Service protective zones around the President and his motorcade. During a visit to Jacksonville, OR, President Bush decided to stop at a local restaurant for dinner. The Secret Service ordered protesters in front of the restaurant be moved, all of whom were anti-Bush protestors. The protestors allege viewpoint discrimination; the Secret Service claims the decision was viewpoint-neutral. The Court will likely decide the standard for proving whether a government action is viewpoint-based discrimination against speech.

<u>Lane v. Franks</u>: The Court will hear a case in which an employee claims he was retaliated against (terminated) for testifying in response to a lawfully-issued subpoena. Distinguishing the former case of <u>Garcetti v. Ceballos</u>, the employee argues testifying was not a part of his job duties, and therefore, he has a First Amendment claim against his employer for retaliation against him for speaking out on a matter of public concern. <u>Garcetti</u> held public employees cannot pursue First Amendment claims for speech they engaged in as a part of their job duties.

#### **<u>Reported previously:</u>**

<u>McCullen v. Coakley</u>: The Court will decide whether Massachusetts's selective exclusion law violates the First Amendment. The law makes it a crime for speakers other than clinic "employees or agents . . . acting within the scope of their employment" to "enter or remain on a public way or sidewalk" within thirty-five feet of an entrance, exit, or driveway of "a reproductive health care facility."

<u>Harris v. Quinn</u>: The Court will hear arguments on whether a collective bargaining agreement that requires state-employed, Medicaid home-care personal assistants to pay a fee to a union representative violates the First Amendment, regardless of the amount of those fees or how the union uses them. The Court will also hear arguments on a justiciability question, which may dispose of the case without reaching the First Amendment issue.
