## **NMPW Communications Contest Opens**

The annual New Mexico Press Women's Communications Contest recognizes excellence across a broad range of media. Contest winners are announced at the NMPW Awards Banquet on Saturday, March 21, 2020, and first-place winners will advance to the National Federation of Press Women's Communications Contest.

The contest opened Oct. 1, 2019. Book entries are accepted until midnight Feb. 4, 2020. All other entries are accepted until midnight Feb. 11, 2020. All entries received after the early-bird deadline of Jan. 28, 2020, will be charged a one-time \$25 late fee by the national organization.

The Communications Contest is open to anyone over the age of 18, regardless of gender, professional status or location. Collegiate entrants do not have to be over 18 years of age.



There are 61 categories encompassing all types of writing, broadcasting, radio, video, podcasting, editing, photography, graphics and design, web and social media, advertising, communications programs and campaigns, public relations materials, information for the media, speeches, and collegiate/education. Entry fees for the contest are as follows:

### For members of New Mexico Press Women:

\$25 for the first entry and \$15 for each additional entry.

#### Non-members:

\$30 for the first entry and \$20 for each additional entry.

#### Collegiate entries: \$10 per entry

Edward Harness, Executive Director of Albuquerque's Civilian Police Oversight Agency spoke to Albuquerque Press Women and Friends on Monday, Oct. 14, at at Mimi's Cafe about the agency and the way it

is working. He will also discuss issues of current concern.

Harness is a graduate of Marquette University Law School. Prior to law school, as a City of Milwaukee Police Officer, he graduated Cum Laude with a Bachelor of Arts in Management of Criminal Justice Operations from Concordia University. He is a native Californian, served in the U.S. Army as a Military Policeman, and a City of Milwaukee Police Officer. Mr. Harness also served seven years as a volunteer Police Commissioner in Wisconsin.

During his 15 years in private practice of law, he was recognized as one of Milwaukee's Top Rated Attorneys. His practice areas were Consumer Rights, Foreclosure Defense, Mortgage Modifications, and bankruptcy. For a time he served on the US Postal Service's Mediation Panel, and was the Director of the Better Business Bureau's Dispute Resolution Center.

In September 2015 the Civilian Police Oversight Agency Board selected him to be the first Executive Director of the CPOA. Albuquerque Press Women and Friends meet monthly on the second Monday. Anyone is welcome at meetings, but non-members will be charged an additional \$5. Attendees order individual meals directly from the menu. APWF focuses on a wide variety of communication opportunities. At the Nov. 11 meeting, APWF will host Eddie S. Hughes, a long time writer and reporter for the Dallas Morning News. He will talk about the "JFK Assassination, A Reporter Reminisces." Hughes covered the assassination of President Kennedy, and the burial of Lee Harvey Oswald. Hughes spent a long life as a reporter and public relations executive in Texas and New Mexico.
